The Peterite Lounge Rules and Conditions

1. The Lounge is for the exclusive use of its members and their guests.
2. A charge of Rs. 100/- per guest will be levied and shall be paid by the member accompanying the guest upon entry to the Lounge
3. The membership card should be presented to the doorman on duty at the entrance prior to entering the Lounge.
4. The members register, should be signed by the member at the point of entering the premises and the names of all their guest should be included.
5. A member of the lounge should always be present at any function or booking, the member cannot sign guests and leave the lounge, while their guest continues to patronize the lounge.
6. Members and guests should conduct themselves with decorum while in the premises. Members are ultimately held responsible for their guests' behavior.
7. No abusive or obscene language or violent behavior will be permitted in the lounge.

Food and Beverage

8. All food must be purchased and consumed inside the Lounge. (Not applicable for Take Away packs)
9. The lounge membership number must be mentioned when placing all Food & beverage orders.
10. Food purchased from outside is strictly prohibited from being brought into the Lounge.
11. Members are allowed to consume their own liquor in the Lounge, but chasers and all other beverages must be purchased from the Lounge.

12. Dress Code

13. Members and their guests should be always attired appropriately.
14. Acceptable attire will be - Smart Casual, members & their guests will not be permitted to enter in shorts, slippers, sandals, sleeveless Tshirt etc.

Entertainment

15. TVs and sound systems are available to provide entertainment to the Members as a whole.
16. The equipment is only allowed to be operated by the members of the staff and the Lounge management committee.
17. Preference of music and TV channels are determined by the members of the staff and Lounge management committee.
18. Members are hereby strictly prohibited to use any of the furniture or lounge property as musical instruments but may be allowed to bring in their own instruments and play with the consent of the Lounge manager or the Lounge Steering Committee Chairman &/ or OBUH Secretary. However, it must be noted that it should not be a nuisance to the other members present.

The Manager

19. The Manager has the authority and responsibility to ensure that the rules are implemented & followed to ensure a smooth operation of the Lounge.

Lockers

20. Lockers are allocated to Life members as a priority, ordinary members will also have access to lockers, based on a first come first serve basis.
21. The locker fee should be paid every year before the 15th of January; if not, the locker will be allocated to another member.
22. The Key's to the lockers will remain in the custody of the lounge in the lounge Key cabinet.
23. A duplicate key will remain with the Lounge Manager at any given time (Manager OBUH).
24. Only the following designated people will have access to open the lockers, the OBUH Manager Lounge, OBUH Chairmen, OBUH Secretary & the OBUH Membership lead.
25. A locker will only be opened at the locker owner's personal request or if there is a need to clear a locker due to non-payment.

Personal functions:

26. Bookings and allocation of space for private functions will be entertained at the strict discretion of the Steering Committee.
27. Life members will be given priority to their bookings with preferential rates.
28. Ordinary members, who have paid their annual subscriptions will also be allowed to book designated areas, based on availability and at a published rate.
29. The rate for the areas will be structured and would apply to all parties throughout a period determined by the Steering committee of the OBUH.
30. The OBUH reserves the right to update and review the rates and make the necessary changes without prior notice.

Other Rules and Conditions

31. There are other rules and conditions applicable relating to the operation of the Lounge, such as the conduct of members, and discipline with which the members are expected to adhere to.
32. The OBUH Steering Committee management and the manager of the lounge have the authority to make decisions to ensure the smooth functioning of the Lounge, these committees reserve the right to excise and take the necessary decisions to support the lounge objectives and activities keeping the best interest of its membership in mind.
33. If any member is found to have been violating any of the said rules or conditions, he may be banned from entering the premises and may face the possibility of suspension. Depending on the severity of the offense, the membership status may be terminated if found in breach of the terms and conditions, following an inquiry by the designated party.
34. If any damages are incurred to any of the property of the Lounge, the member will be held responsible for this liability and will need to bear the cost of replacement or repair.
35. The Steering Committee of the OBUH reserves the right to update these Rules & Conditions from time to time, to make them more relevant based on prevailing operational conditions.
